CLARIFICATION AND CONSENT TEXT REGARDING THE PROCESSING OF PERSONAL DATA

We would like to inform you about Personal Data Protection Law no: 6698 which was introduced to protect the fundamental rights and freedoms of persons, privacy of personal life in particular while personal data are processed, and to set forth obligations of natural and legal persons who process personal data and procedures and principles to comply with for the same.

Within the scope of this law, personal data is described as “any information relating to an identified or identifiable natural person” and processing of personal data is described as “any operation which is performed upon personal data such as collection, recording, storage, preservation, alteration, adaptation, disclosure, transfer, retrieval, making available for collection, categorization or blocking its use by wholly or partly automatic means or otherwise than by automatic means which form part of a filing system”.

1. Purpose of the Clarification Text and the Position of the Data Controller of European Union Sivil Düşün Programme

European Union Sivil Düşün Programme brings the explanation below to the attention of MIS members, e-bulletin subscribers and 3rd persons using our website in order to fulfill the responsibility required by the 10th article of the Law on the Protection of Personal Data no. 6698 (“LPPD”) regarding the Management Information System and Sivil Düşün e-bulletin subscribers (which will be referred to as MIS members and e-bulletin subscribers hereinafter). European Union Sivil Düşün Programme always reserves the right to update this explanation text about personal data protection herein within the framework of any changes made upon the prevailing legislation.

2. The Purpose of Processing and the Transfer of Recorded Personal Data

Your personal data is used with these purposes:

- To confirm the credentials of members signing up through web sites/mobile applications,
- To register address and other necessary information for communication,
- To get in touch with MIS members and e-bulletin members, to provide necessary information and to convey campaign and questions,
- To prepare all the records and the documents which will form the basis for the procedure electronically (internet/mobile, etc.) or on paper,
- To inform public officers regarding matters of public security should it be requested and as required by the legislation.

- To improve the satisfaction of MIS members, e-bulletin subscribers and web site users, to form surveys on an electronic and/or physical platform.
- To offer proposals to MIS members and e-bulletin subscribers via our contracted institutions, solution partners, and 3rd party internet mediums and digital programs of which we are members; to inform MIS members and e-bulletin subscribers regarding our services.
- To evaluate member complaints and suggestions regarding our campaigns.
- To perform our legal obligations and use our rights given by the prevailing legislation.
- To avoid fraud and other illegal activities.

The sharing of personal data of MIS members and e-bulletin subscribers with 3rd parties take place with the permission of MIS members and e-bulletin subscribers, and personal data can't be transferred to 3rd parties without the approval of MIS members and e-bulletin subscribers.

However personal data will be shared with courts and other public institutions if required, only due to our legal obligations.

Necessary technical and legal precautions are taken to avoid violation of rights during data transfer to 3rd parties.

3. Collection Method of Your Personal Data and the Legal Reason

Personal data is processed by Sivil Düşün with the consent of MIS members and e-bulletin subscribers and as required by the prevailing legislation. Personal data collected due to legal reasons mentioned above can be processed and transferred with the purposes stated in the 5th and 6th articles of the personal data law and the purposes stated in this clarification and consent text.

4. User Rights of the Data Subject

In accordance with the 11. article of the law, data subjects have the right to:

- a) Learn whether or not her/his personal data have been processed;
- b) Request information as to processing if her/his data have been processed;
- c) Learn the purpose of processing of the personal data and whether data are used in accordance with their purpose;
- d) Know the 3rd parties in the country or abroad to whom personal data have been transferred;
- e) Request rectification in case personal data are processed incompletely or inaccurately; and request notification of the third parties to whom personal data have been transferred;
- f) Request deletion or destruction of personal data even if the personal data is processed in accordance with this law or relevant other laws in case the reasons necessitating their processing

cease to exist. Request notification of the operations made to third parties to whom personal data have been transferred;

g) Object to occurrence of any result that is to her/his detriment by means of analysis of personal data exclusively through automated systems and request compensation for the damages in case the person incurs damages due to unlawful processing of personal data.

European Union Sivil Düşün Programme will evaluate and finalize the relevant requests within 30 days. European Union Sivil Düşün Programme reserves the right to demand a fee within the range of the fee rate (if any) determined by Personal Data Protection Commission.
